



1. LICENSE GRANT

Provided that you comply with all terms and conditions of this End User License Agreement (“EULA”), the International Automotive Oversight Bureau (IAOB) grants to the user (“you” or “your”) a personal, non-exclusive, non-transferable license to install and use one copy of IAOB Software (“Software”) for your internal use. You may make a single backup copy of the Software, provided it remains in your possession and control.

2. RESTRICTIONS ON USE

You may not: (i) directly or indirectly re-package or incorporate any portion of the Software into any other product; remove any proprietary notices, trademarks, or labels on or embedded in the Software or Documentation; (ii) permit other persons or entities to use the Software; (iii) directly or indirectly modify, translate, reverse engineer, decompile, disassemble, or create derivative works based on the Software or Documentation or any part thereof, except and only to the extent that such activity is expressly permitted by applicable law; or (iv) lend, lease, or otherwise transfer the license rights to the Software or Documentation without prior, written permission of IAOB.

3. OWNERSHIP

The Software is protected by copyright and other intellectual property laws and treaties. All right, title, and interest in and to the Software and Documentation, including any copies, shall at all times remain exclusively vested in IAOB, including without limitation all copyright and patent rights. Third-party suppliers are intended beneficiaries under this Agreement and independently may protect their rights in the Software in the event of any infringement. All rights not expressly granted to you are reserved solely for IAOB or its suppliers.

4. MAINTENANCE; UPGRADES

This license does not grant you any right to any enhancement, update, or maintenance services (except for the warranty service expressly provided below). New versions of the Software or maintenance updates, if available, may be ordered separately or may be available through the Help Desk. IAOB reserves the right to require additional licenses and fees for any such versions or maintenance.

5. COLLECTION AND USE OF INFORMATION

IAOB collects and uses the information that you generate, upload, submit, or otherwise provide in the Software. By providing this information you consent to these uses or those noted in IAOB’S Privacy Policy.

IAOB may, directly or indirectly through the services of others, collect and store information regarding the use of the Software and about equipment on which the Software is installed or through which it otherwise is accessed and used, by means of providing maintenance and support services and security measures included in the Software.

You agree that the IAOB may use such information for any purpose related to any use of the Software by you, including but not limited to: (i) improving the performance of the Software or developing updates; and verifying compliance with the terms of this Agreement and enforcing IAOB’s rights, including all intellectual property rights in and to the Software.

6. EXPORT RESTRICTIONS

You acknowledge that the Software is subject to U.S. export jurisdiction. You agree to comply with all applicable international and national laws that apply to the Software, including the U.S. Export Administration Regulations, as well as end-user, end-use, and destination restrictions issued by U.S. and other governments.

7. WARRANTY

IAOB’S SOFTWARE WILL MATERIALLY CONFORM TO ITS DESIGN SPECIFICATIONS FOR A PERIOD OF NINETY (90) DAYS FROM YOUR PURCHASE OF THE SOFTWARE. IAOB WARRANTS THAT ANY PHYSICAL MEDIA CONTAINING THE SOFTWARE WILL BE SHIPPED FREE OF VIRUSES.

8. DISCLAIMER OF WARRANTIES

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IAOB PROVIDES THE SOFTWARE “AS IS” AND WITH ALL FAULTS, AND DISCLAIMS ALL OTHER WARRANTIES AND CONDITIONS, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES, DUTIES OR CONDITIONS OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE WITH REGARD TO THE SOFTWARE.
